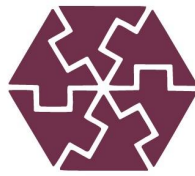

Outcome of Planning Advice Call – 3 Bed, 2 Child Children's Home 11/05/2026

1. Use Class Decision

- The officer confirmed this will NOT fall under C3.
- Because the children require care and staff will be present, the council will treat it as C2 (Residential Institution).
- A Change of Use application is required.

2. Type of Application

- We must submit a standard full planning application for Change of Use to C2.

3. Required Documents

The officer listed the following mandatory documents:

1. Location Plan – 1:1250 scale
2. Block Plan – 1:500 or 1:200 scale
3. Existing Floor Plans
4. Proposed Floor Plans (even if no changes – just re labelled)
5. Existing Elevations
6. Proposed Elevations (again, even if unchanged)
7. Cover Letter / Supporting Statement explaining:
 - o 2 child model
 - o Family style environment
 - o Staff presence
 - o No physical alterations
 - o Parking availability
 - o Low neighbourhood impact

All plans can be purchased digitally if we don't already have them.

4. Application Form Notes

- Most of the form will not apply (80–90% irrelevant).
- We must complete the Change of Use section only.
- Certificate A if we own the property.
- Certificate B if we are leaseholders.
- The portal will require us to draw the site boundary on the map before submission.

5. Committee vs Officer Decision

- Whether it goes to planning committee or stays officer delegated will be decided by the local authority after submission.
- Typically, these applications are officer level unless there are significant objections.

6. Timeframe

- Standard decision period: 8 weeks from validation.

7. Risks / Mitigation

- No major risks identified.
- The officer advised that the cover letter should clearly justify:
 - o Why the home is needed
 - o How the children will be cared for
 - o How the environment will remain family like
 - o Parking and neighbourhood impact
- This will help avoid delays or objections.

8. Submission

- Application must be submitted via the local authority's planning portal (Reading Council in this case).
- The officer confirmed this is a straightforward process.
